About 70 percent of Disha's children come from poorest of the poor families living in the slums and adjoining rural areas and receive all the therapies and services including transportation, nutritious meal, medical intervention etc. **free of charge**.

Pre-vocational and Vocational Skills Development

Vocational skill-oriented training is an integral part of the Rehabilitation Program. This is designed to impart need based skill training to disabled persons between 15-35 years of age. The purpose of training is to develop a sense of self esteem and to gain social acceptance by becoming meaningfully employed in a vocation of self aptitude and is aimed in particular.
