# Que. Use of Mobile Application

**Ans.** It would involve creating an Android Smartphone application for the administrators that would leverage on the functionalities of the existing system to aid the users in various monitoring and communication mechanism. The Application includes the monitoring of the ongoing project through field officer (User ID will provide to the filed officer to input the Data, Input Data will verify by the Project officer before publishing on the Mobile Application and Web Portal) All ongoing projects, Completed Projects and Other activities which may be link up directly with GCSRA's Web Portal).

## Que. How many Prototype will require in the Technical Presentation?

Ans. Minimum 2

#### Que. About GCSRA and its requirement.

Ans. Kindly refer GCSRA's website i.e. <u>www.gcsra.org</u>. This web portal should be knowledge sharing portal which will cover all aspects of CSR.

Que. Is the Biometric instrument cost is included in the tender?

Ans. Hybrid Platform can be used.

- Admin panel static data will be displayed in Gujarati, Hindi & English languages.

- Total Period of 3 years including 6 months for the development work and 2.5 years for the maintenance work
- After the completion of the development work, GCSRA requires on site management person for initial six months from the agency.
- GCSRA will reimburse the payment gateway cost to the agency;
- The website will be deployed on the State data centre of Gujarat.
